The Licensing Act provides a system of permitted temporary activities for licensing activities which do not have to be authorised by the Council via an application. Someone wishing to hold such an event gives a notice of this to the Council and if there are any concerns only the Police or Environmental Health can object to the application and in this case neither did. The temporary activities are time limited and the premises sold alcohol during December and January, the sale of alcohol is no longer permitted at the premises.

It is a different system for the permanent licence, where objections are received to an application for a Premises Licence the Committee must determine the application.
