#### **Executive summary**

To seek Executive approval of the Middlesbrough Council tender pipeline for 2023/4 including the delegation of responsibility for award to the relevant Director in consultation with their Executive member and to approve the development and publication of the new Corporate Procurement Strategy 2023-26.

This decision is being sought in line with governance arrangements for tenders undertaken by the Council.

## Purpose

1. To approve Middlesbrough Council's tender pipeline for 2023/24 and agree delegation of award to the relevant Director in consultation with their Executive Member and the development and publication of the Corporate Procurement Strategy 2023-26.

## Background and relevant information

- 2. A tender pipeline for April 2023 to 31<sup>st</sup> March 2024 has been developed as part of our governance processes this report seeks Executive approval for that planned procurement activity and delegates authority for contract award to the relevant Director in consultation with their Executive Member.
- 3. The tender pipeline for 2022/23 had 28 tenders proposed and below is an update on them all:
  - ➤ 18 Tenders have been awarded
  - ➤ 5 Tenders are currently ongoing
  - > 1 Tender did not progress and is no longer required
  - 4 Tenders publications dates were delayed and will now be published in 2023/24
- 4. Please note the 4 tenders delayed for publication have been included in the Tender Pipeline 2023/24 for audit purposes.
- 5. The tender pipeline will be a live record which will be maintained by the Commissioning and Procurement Team and available for the supplier market to view on the Council's website.
- 6. In the event that new tenders are required during the year then Individual Executive reports will be presented. Please note this should be minimal because this should only occur where new funding is available.
- 7. Middlesbrough Council's Corporate Procurement Strategy ends in 2023 and a new three year strategy will be co-produced and published later in the year. The corporate procurement strategy sets out the Council's approach to procurement and is published on our website.
