(F) Land in the area of the Authority

Address or other description (sufficient to identify the location) of any land in which I have a beneficial interest and which is in the area of the Council

(G) Corporate Tenancies

Address or other description (sufficient to identify the location) of any land where the landlord is the Council and the tenant is a firm in which I am a partner, a company of which I am a remunerated director or a body of the description specified in (d) above

(H) Licenses to occupy land

Address or other description (sufficient to identify the location) of any land in the Council's area in which I have a licence (alone or jointly with others) to occupy for 28 day or longer

Other Interests

(A) Representing the Council

I am a member or hold a position of general control or management of the following body(ies) to which I have been appointed or nominated by the Council as its representative

(B) Other Public Authorities


