# Priorities

- Reduce the number of permanent exclusions and suspensions across the town
- Ensure sufficiency of school places for all children and young people
- Improve attendance for all children and young people
- Monitor the number of children choosing Elective Home Education
- Increase inclusion within mainstream settings for children with an EHCP
- Ensure EHCA are completed within the 20 weeks statutory process
- Support schools and settings to have a skilled workforce
- Reduce the number of children and young people accessing out of area specialist provision
- Reduce the deficit on the High Needs Budget
- Improve outcomes for all children and young people

# Current Projects

- SHiFT
- Adopting a digital support system that embraces, Education, Early Help and Social Care
- Improving Attendance
- Introduction of a new Resource Allocation System to support children with an EHCP
- Review of specialist provision
- Family Hubs

# Challenges

- Exclusions and suspensions
- Funding
- Sufficiency of Alternative Provision placements
- Sufficiency of Specialist Placements
- Attendance
- Increasing number of children who are Electively Home Educated



# Corporate Performance Measures

- Permanent exclusions : Currently 88, slightly lower than previous year
- Suspensions: Reduction in the days lost per pupil, suspensions rates are slowing
- Attendance: 92.5%
- Elective Home Education currently: 321
- Completion of an EHCP within 20 weeks: 97%
- Inclusion within mainstream settings for children with an EHCP: 39.2%
- Children currently accessing Alternative Provision: 377
