Community Governance Review

Introduction

Middlesbrough Council is undertaking a Community Governance Review to decide future parish council, community council and other local arrangements within the area.

This review will run from XX 2021 to YY 2022 and will involve two public consultations.

The first consultation will gather the ideas of local communities. The second will make concrete proposals on future arrangements.

What is a Community Governance Review?

Principal councils like Middlesbrough Council have the responsibility for undertaking community governance reviews.

A community governance review decides whether parish councils will exist in the area and the boundaries and electoral arrangements for these councils.

The process for carrying out a community governance review is set out in the Local Government and Public Involvement in Health Act 2007 and associated guidance published by the Boundary Commission, which you can find here:

Why are we consulting?

A community governance review must take account of the views of local people.

We want your views on current parish council arrangements in the Middlesbrough Council local authority area and whether these should change in the future.

However as parish councils do not work in isolation, we also want your views on local community councils and how Middlesbrough Council can work together with parish councils and all other local structures to better engage with you and your community in the future.

This is the first Community Governance Review that Middlesbrough Council has ever undertaken and they are usually only undertaken once a decade, so make sure you have your say!

How can I take part?

You can take part by completing our survey, either online or picking up a paper copy from Middlesbrough House Customer Centre or one of the Council's community hubs or libraries.

What happens next?

The feedback from this consultation will be considered by Middlesbrough Council's Corporate Affairs and Audit Committee on XX/XX 2022.

A community governance review will not automatically result in any changes to arrangements within Middlesbrough, but if any are considered necessary then a further consultation on any proposed changes will take place between XX and YY 2022.

A final decision about any changes would then be made by full Council on XX/XX 2022.

If approved, a Reorganisation Order will then be made to put the recommendations into effect in time for the next elections for town and parish councils in May 2023.




